Four weeks' time, as last opportunity, is granted to respondent nos. 1, 2, 21, 30, 31 and 42 to file counter affidavit. Respondent nos. 23, 29, 33, 37 and 41 have already filed counter affidavit.

None appears for respondent nos. 3, 4, 7, 8, 11, 14, 15, 18, 24, 25, 32, 35, 36 and 40 despite due service.

Respondent no. 42 has to file the counter affidavit within four weeks' time.

Learned Counsel for the appellant shall take fresh steps for

effecting service on respondent nos. 5 to 6, 9, 12 to 13, 16, 17, 19, 20, 22, 29, 34, 37, 39 and 43 to 44 within two weeks and notice thereafter, be issued.
