O R D E R

I.A. No. 7 (Application for impleadment)

The application is dismissed.

I.A. No. 8 in I.A. No.3

This is an application filed by Dastak, N.G.O. through its President Anand Singh Rathore. The prayer in this application is to direct the State of Rajasthan to stop mining of minor minerals without taking prior environmental clearance from MOEF and modify the order dated 27.03.2014 to that extent.

It may be mentioned that the State of Rajasthan has filed a reply to the application being I.A. No. 8.

The remaining parties may file a reply within two weeks.

I.A. No. 8

This is a reply on behalf of State of Rajasthan to the application for directions filed by Dastak, N.G.O. Since a reply is not required to be given in an I.A., this I.A. is disposed of for statistical purposes only.

I.A. No. 9 (Application for directions)

This is an application filed by Bajri Lease Letters of Intent Holders.
