We have heard the learned counsel appearing for the appellant and the learned counsel appearing for the sole respondent.

Aggrieved by the impugned order dated 7-10-2015 passed by the High Court of Madhya Pradesh dismissing the Criminal Revision No.2501 of 2015 filed by the appellant, the appellant has filed this appeal challenging the dismissal of the said revision petition.

It is brought to our notice that the learned counsel appearing for the respondent has compromised with the appellant vide Compromise Deed dated 23-12-2016 and the respondent has received the entire outstanding amount from the appellant.

Since the entire amount is received by the respondent and he does not want to pursue the matter further, he has no objection if the impugned order passed by the High Court dismissing the revision petition of the appellant is set aside.

In view of the above, the order dated 7-10-2015 passed by the High Court of Madhya Pradesh dismissing the Criminal Revision filed by the appellant is set aside.

Needless to say that the order dated 14-11-2017 granting exemption from surrendering to the appellant is made absolute.

The Appeal is allowed in the afore-stated terms.
