Heard learned counsel appearing for both the parties and perused the averments made in the instant petition.

Mr. D. Sreenivasan, learned counsel representing Ms. Lakshmi Ramamurthy, AOR for the respondent states that respondent has no objection if the matter is transferred.

Having considered the submissions made on behalf of the parties and the grounds on which transfer has been prayed for, O.P. No.375 of 2019 titled as '*Valluru Vamsi Krishna Reddy Vs. Smt. Valluru Srinija*' pending before the Family Court, Ranga Reddy District at Kukatpally, Telangana is ordered to be transferred to the Family Court, Ramesh Reddy Nagar, SPSR Nellore, Andhra Pradesh for hearing and disposal in accordance with law.
