O R D E R

Application for impleadment is allowed.

It is stated at the Bar that both the parties to the  
*lis* have settled the matter amicably. We accept the  
statement.

As a consequence thereof, the criminal prosecution  
initiated against the petitioner in connection with F.I.R.  
No.154 of 2015 dated 2<sup>nd</sup> August, 2015 under Sections  
420/120B/34 of the IPC is hereby quashed.
