O R D E RWe have heard learned senior counsel for the
respective parties.

The impugned order dated 23.04.2019 passed in CrI.O.P.No.6545 of 2018 and CrI.M.P.No.3349 of 2018 by the High Court of Judicature at Madras, is stayed until further orders.

In the circumstances, the respondent No.3-State is directed to conclude the investigation vis-a-vis First Information Report in Crime No.282 of 2017 dated 28.12.2017, which is registered at Grand Bazar Police Station, Puducherry in respect of offences under Sections 147, 148, 448, 294(b), 506(ii), 468, 471, 420 read with 149 of the Indian Penal Code, 1860.

It is needless to observe that respondent Nos.1 and 2 have the benefit of anticipatory bail in their favour. However, they shall cooperate with the investigation.

The respondent No.3-State shall conclude the investigation within a period of three months from today and file a report before this Court.
