O R D E R

Leave granted.

By a judgment dated 27.11.2010, divorce was granted to the husband on two grounds. In the meanwhile, the appellant got re-married on 15.07.2011 and a son has been born from the fresh marriage on 07.07.2012. However, by the impugned order dated 18.12.2017, the judgment dated 27.11.2010 has been set aside, as a result of which the divorce that was granted no longer obtains.

Having gone through the impugned judgment and in the interest of justice, we are of the view that the marriage having broken down cannot possibly be said to subsist. Even otherwise, we do not uphold the impugned judgment except to the extent that a sum of Rs.10,00,000/- (Rupees Ten Lakhs) lumpsum payment has been ordered to be made to the couple's daughter. We may only indicate that, in addition, a sum of Rs.3,00,000/- (Rupees Three Lakhs) will be paid to the respondent within a period of nine months from today.

The appeals are allowed in the aforesaid terms.
