Having heard learned counsel appearing on behalf of the respective parties and having gone through the allegations in the complaint and in absence of any specific allegation that right from very beginning, it was the intention of the respondents to deceive the complainant and there was a dishonest intention on the part of

the accused from the very beginning and that the complainant relied upon the assurances given, the High Court has rightly quashed the criminal proceedings in exercise of powers under Section 482 of the Code of Criminal Procedure, 1973.

At this stage, it is required to be noted and it is not in dispute that even the complainant has already filed a substantive suit for specific performance before the competent Civil Court. In that view of the matter, no interference of this Court is called for. The Special Leave Petitions stand dismissed.
