Heard the learned Senior counsel appearing for the appellant and the learned counsel appearing for the respondent(s).

This is a case where the appellant-plaintiff had filed a suit for partition and possession of half share in the suit schedule property. The suit came to be partly decreed declaring the appellant and defendant Nos. 1 to 4 to be the owners of one-fifth share each, in the suit schedule property and accordingly, the appellant was found entitled to get his share partitioned, and obtain possession of the same. On a first appeal preferred by the appellant, the High Court, vide order dated 06.08.2013 confirmed the order of the Trial Court. Thereafter, the Review Petition filed by the appellant, challenging the order passed in the first appeal, came to be

dismissed, vide order dated 21.07.2016. Aggrieved by the same, the appellant is before us.

We have perused the impugned orders. As the decisions have been rendered concurrently, we find no reason to interfere with the same.

The appeals are, accordingly, dismissed.
