O R D E R

We have heard Mr. Rakesh K.Khanna, learned senior counsel for the appellants and Mr. Kuljeet Rawal, learned counsel for the respondents.

For the reasons stated in the application, the appellants are permitted to deposit Demand Draft No.010793 for Rs.49,58,230/- (Rupees forty nine lakhs fifty eight thousand two hundred thirty) and Demand Draft No.010792 for Rs.59,49,876/- (Rupees fifty nine lakhs forty nine thousand eight hundred seventy six) total aggregate amount of Rs.1,09,08,106/- (Rupees one crore nine lakhs eight thousand one hundred and six) decretal amount plus interest before the Registry of this Court within a week from today.

However, we make it clear that in our judgment dated 01.10.2020, we have awarded simple interest at the rate of 9% per annum.

Liberty is reserved to the respondents to withdraw the amount and if there is any dispute in relation to the calculation of interest, respondents are free to inform the learned senior counsel for the appellants. If the grievance of the respondents still persists and not redressed, liberty is reserved to move this Court.

Miscellaneous Application stands disposed of.
