The instant petition is filed by the petitioner-wife seeking transfer of the petition registered as RCS HM No. 188 of 2019, titled as "*Dr. Dev Narain Shukla Vs. Dr. Ajita*" pending before the Court of the Principal Judge, Family court Mandsaur (M.P.) to the Principal Judge, Family Court, Agra, Uttar Pradesh. That petition has been instituted under Section 13 of the Hindu Marriage Act, 1955.

Having heard Advocates for the parties and on going through the petition, I am satisfied that it would be in the interest of justice to transfer the pending petition to the Family Court, Agra, Uttar Pradesh.
