Having heard learned counsel for the petitioner and having considered the pleadings, the Court is of the opinion that request for transfer is warranted. Accordingly, Matrimonial Suit No. 81 of 2019 titled as "Sri Biswajit Ganguly versus Smt. Sudeepta Ganguly", pending before the Court of District Judge, Alipore, District 24 Parganas (South), West Bengal is hereby transferred to the Family Court, Ahmedabad, District Ahmedabad, Gujarat.
