O R D E R

Leave granted.

This appeal arises out of an interim order dated 07.10.2016 passed by the High Court of Karnataka at Bangalore in Writ Petition No. 53580 of 2016 (GM-CPC) in and by which, the High Court issued notice and granted stay of further proceedings in O.S. No. 26777 of 2011.

Be it noted that vide order dated 11.05.2016 in SLP (C)...CC Nos. 8736-8738 of 2016, this Court directed the trial court/Additional City Civil Judge, Bangalore to dispose of Original Suit No. 26777 of 2011 expeditiously and preferably within a period of six months from the date of production of the copy of the order.

Thereafter, the suit was taken up for trial. The appellants, who are the defendants in the suit, filed an application to bring on record the legal representatives of the first Defendant namely, K.B.

Yellappa Reddy, which was allowed by the trial court by order dated 01.10.2016.

Being aggrieved, the respondents herein, namely, the plaintiffs, filed Revision by way of abovementioned writ petition.

Since there is an earlier direction of this Court vide order dated 11.05.2016 to expedite the hearing and trial of the suit and disposal within a period of six months, we request the High Court to dispose of Writ Petition No. 53580 of 2016 (GM-CPC) expeditiously and preferably by the end of April, 2017.

We direct the parties to extend their cooperation, without praying for unnecessary adjournments, so that the writ petition may be disposed of within the time stipulated above.

In view of the above, the appeal is disposed of.
