O R D E R

The Division Bench of the High Court of Judicature at
Bombay by its order dated 27 August 2019 have granted ad
interim relief in terms of prayer clause (c) and (d)
pending the disposal of the petition which was directed to
stand over to 18 September 2019. Hence, we are of the

view that it would be appropriate to request the High Court to dispose of the petition expeditiously and preferably within a period of two months from the receipt of a certified copy of this order. In the event that the High Court is not able to do so due to the exigencies of work we grant liberty to the petitioner to move the High Court for vacating the ad-interim order dated 27 August, 2019, which application shall be taken up expeditiously, within the above period.

With the above observation, the Special Leave Petition is disposed of.
