O R D E R

SLP(C) No. 9712/2017

SLP has been abated against deceased Respondent No.1 vide order dated 17.01.2025 of the Hon'ble Judge in Chambers.

Opportunity to file counter affidavit has already been declined in respect of Respondent Nos. 2, 3 and 5 to 9 vide order dated 24.8.2018.

Four weeks time is granted to Respondent Nos. 11 and 12 to file counter affidavit.

Service is complete on the remaining respondents but none has entered appearance.

List again on 17.7.2025.

SLP(C) No. 12101/2017

Opportunity to file counter affidavit has already been declined in respect of Respondent Nos. 1, 3, 5, 6, 7 vide order dated 24.8.2018.

Counter affidavit has already been filed in respect of Respondent Nos. 9 and 10 by earlier Ld. Counsel.
