O R D E R

1. Heard learned counsel for the parties.
2. The matter in dispute pertains to the amount to be kept in a fixed deposit. The same has been kept in a fixed deposit by the HDFC Bank.
3. Certain directions have been issued. However, finally it has not been determined by the NCLAT that HDFC Bank will have no lien to appropriate the money towards the dues. It has been accepted that appeals are pending. The appeals which were pending have been heard now finally by the NCLAT is not disputed at the Bar.
4. In view of the aforesaid facts, NCLAT has to decide whether HDFC Bank can appropriate the amount which has been kept in a fixed deposit, in the appeals which have been heard and reserved for orders.
5. In view of aforesaid, we are not inclined to interfere in this matter. Accordingly, the appeals are disposed of.
6. The NCLAT not to be influenced by any observations made in the impugned order.

7. Pending application(s), if any, shall stand disposed of.
