O R D E R

1. These appeals are against an interim order passed by the Appellate Tribunal for Electricity¹, New Delhi pending disposal of an Appeal No. 331 of 2018. We are informed that the appeal is yet to be taken up and disposed of by the Tribunal.

2. Pending disposal of the appeal before the Tribunal, this Court passed the following interim order dated 18.02.2020:

“Issue notice on the applications.
In the meantime, there shall be interim stay the contempt proceedings pending before the appellate Tribunal for Electricity, New Delhi.

...”

3. Mr. M.G. Ramachandran, learned Senior Advocate appearing for the respondents submits that his clients shall not proceed with the contempt proceedings pending disposal of the Appeal No. 331 of 2018. In view of the statement made by Mr. Ramachandran, we see no reason to continue the Civil Appeals, particularly because the order impugned is against an interim order.

4. In view of the above the Civil Appeals are dismissed accordingly.
