Heard the learned counsel appearing for the petitioner.

The Office Report dated 26<sup>th</sup> October, 2021 records that the service of notice of this petition has been effected through the Trial Court. The respondent has not caused appearance. The learned counsel appearing for the petitioner states that Transfer Petition (Civil) No. 2249 of 2017 was filed by the petitioner for transfer of the Divorce Petition, which is no longer pending as the Divorce Petition has been disposed of.

The petitioner is the wife and the respondent is the husband. It is pointed out that the Petitioner-wife is a resident of Delhi and the Respondent-husband is a resident of Rohtak, Haryana. The respondent has filed a petition under Section 7 read with Section 25 of the Guardian and Wards Act, 1890 in the Family Court at Rohtak, Haryana. The ground for transfer is that the petitioner-wife is working

in a school in Najafgarh, Delhi and she has to maintain two minor children. Her contention is that she finds it difficult to attend the Court proceedings in the Family Court, Rohtak, Haryana.

There is no contest by the respondent. In view of the grounds made out, Transfer Petition is allowed and accordingly Case No. Gw/22/2019 of 2019 titled as "*Sunil Hooda Vs Monika*", which is pending in the Family Court, Rohtak, Haryana, is hereby transferred to the Court of the Principal Judge, Family Court, Dwarka, Delhi.
