This transfer petition has been filed by the petitioner-wife under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of HMA Petition No. 694 of 2017 titled as "Ankit Trivedi vs. Aarti Trivedi", pending before the Court of Principal Judge, Family Court, Raipur, Chhattisgarh to a competent Court of equivalent jurisdiction at Farrukhabad, U.P.

As per office report, service of show-cause notice is complete through service report of Trial Court as well as the postal tracking report. The respondent-husband has not entered appearance despite service.

Having considered the circumstances in their totality, we are of the view that in the interest of justice, transfer of the proceedings, as prayed for, is warranted.
