**UPON hearing the counsel, the Court made the following  
O R D E R**

**I.A. No. 170183 OF 2022 IN WRIT PETITION (CIVIL) NO. 1335/2018:**

1. This application has been filed by the petitioner-wife praying *inter alia* for issuing directions to the Parsi District Matrimonial Court, Surat, to enforce the directions issued by the Vermont Court, USA for implementation of the judgement dated 02<sup>nd</sup> July, 2021, and to direct the respondent no.2-husband to pay USD 5000 per month as interim maintenance.
2. In the course of submissions, we are informed by Mr. Siddharth Bhatnagar, learned Senior Counsel appearing for the respondent no.2-husband that the petitioner-wife has already moved a similar application for interim maintenance, which is pending adjudication before the Parsi

District Matrimonial Court, Surat and is now coming up on 20<sup>th</sup> March, 2024.

3. In view of the aforesaid submission, Ms. Meenakshi Arora, learned Senior Counsel appearing for the petitioner-wife states that the aforesaid application has been pending before the District Court for a fairly long time and has not been decided so far.
4. The District Court at Surat is directed to take up the aforesaid application on the date fixed and dispose it of as expeditiously as possible.
5. The application is disposed of.
