UPON hearing the counsel the Court made the following  
O R D E R

I.A. No.321239/2025

1. Owing to an affidavit filed by the Bar Council of India in WP (C) No. 1319/2023, confirming its commitment to implement representation of 30% for women candidates, this application has become infructuous and is disposed of accordingly.

I.A. No.30149/2026, 30150/2026 & 30152/2026

2. Learned counsel for the applicant(s) seeks and is permitted to withdraw these applications. The Interlocutory Applications are,

accordingly, dismissed as withdrawn.

3. All the interlocutory applications are disposed of with liberty to the applicants to approach the High-Powered Committee headed by Hon'ble Mr. Justice Sudhanshu Dhulia, former Judge of this Court. We request Justice Dhulia to issue necessary instructions and directions to the Bar Council of India or the State Bar Councils, if so required.

4. We further clarify that the Committees headed by former Chief Justices/Judges of the High Courts, constituted for conducting the elections of State Bar Councils, shall have the power to decide the procedural issues that may arise on day-to-day basis. To resolve such issues, it is not necessary to compel the parties to approach this Court.

5. It is only if a prayer is made, which is directly in the teeth of the orders passed by this Court earlier, that the applicant(s) shall be relegated to approach this Court. The Committee shall have the power to issue any necessary directions to ensure transparency, fairness, and smooth conduct of the ensuing elections.

6. The Committees may, whenever required, call for assistance from the Bar Council of India or State Bar Councils through their

learned counsel.

7. Post the main matter on 20.03.2026.
