O R D E R

1. In this petition, prayer has been made for review of order dated 30.10.2017 passed in S.L.P.(C)No.33585 of 2017.
2. The petitioner has also filed an application for condonation of 694 days' delay in filing the review petition. We have perused the averments contained in the application for condonation of delay and are convinced that the explanation given by the petitioner is wholly unsatisfactory. Therefore, the application for condonation of delay is dismissed. As a sequel to this, the review petition is liable to be dismissed as barred by time.
3. Even otherwise, after having gone through the review petition and the record of the special leave petition, we do not find any justification to review order dated 30.10.2017. The review petition is accordingly dismissed as barred by time and also on merits.
4. As a sequel to the above, pending interlocutory applications also stand disposed of.
