O R D E R

The petitioner before this Court is the wife in a matrimonial dispute seeking transfer of Original Suit No.1024 of 2019 instituted by the respondent-husband, Lt. Col. Anil Kumar Chadha. That proceeding is a petition for divorce under section 13 (1) (i-a) of the Hindu Marriage Act, 1955 pending in the Family Court, Gautam Buddha Nagar, Uttar Pradesh. She wants that petition to be transferred to the Court of Additional District and Sessions Judge, District S.A.S. Nagar, Mohali, Punjab.

The petitioner also seeks transfer of another proceeding, bearing Guardianship Petition No.47 of 2019 instituted by the respondent-husband under sections 7, 9, 12 and 25 of the Guardians and Wards Act, 1890 pending in the same Court to the Court of Additional District and Sessions Judge, District S.A.S. Nagar, Mohali, Punjab.

In course of hearing today the respondent-husband is represented by learned counsel, Mr. Bhargava V. Desai. On instructions he submits that his client is willing to accede to the plea of the petitioner-wife for transfer without admitting any of

the allegations raised in the transfer petition.

This being the position, I allow the application for transfer in terms of prayers (a) and (b) of the transfer Petition. None of the allegations made in the transfer petitions, however, shall be deemed to have been admitted by the respondent-husband.

The transfer petitions are allowed.

Both the petitions, being Original Suit No.1024 of 2019 and Guardianship Petition No.47 of 2019 pending in the Family Court, Gautam Buddha Nagar are transferred to the Court of Additional District and Sessions Judge, District S.A.S. Nagar, Mohali, Punjab. The Court of which these cases are transferred shall proceed with the same from the stage at which the proceedings are transferred to it.
