A W A R D

1. The learned counsel appearing for the petitioners and the learned counsel appearing for the respondent-Insurance Company agree that the total amount of compensation payable to the petitioners shall be Rs.18,00,000/- (Rupees eighteen lakhs). The respondent has already deposited the amount payable as per the judgment of the High Court. On the balance amount, interest shall be payable at the rate of 6% per annum from the date of filing of the claim petition till the date of actual payment.

2. We direct the respondent to deposit the additional amount as aforesaid within a period of two months from today with the concerned Tribunal. The Tribunal shall pass appropriate order for disbursement/investment of the amount in accordance with law.

3. The Court Fee be refunded as per Rules.

4. The Special Leave Petition is accordingly disposed of.
