By the detailed judgment dated 13.02.2017, the custody of the child was given to the respondent-mother. It was also directed that a fresh call on the future arrangement shall be taken thereafter. On the last date of hearing, we had interacted with the child. We found that she is happy in the company of her mother. Her education performance is also satisfactory and has improved during the last one year. Even otherwise, going by the age of the female child, it would be proper if the custody continues with the mother.

The school of Saesha is closed for Summer Vacations which started on 11.05.2018. We are informed that her school is reopening on 02.07.2018. We are also informed that Saesha along with her mother is going to Imphal on 24.05.2018 and is returning on 18.06.2018. Under the

aforesaid circumstances, custody of Saesha, for this Summer Vacations shall be handed over to her father on 17.05.2018 and she will return to her mother on 23.05.2018 by 2 p.m. After Saesha returns, from 18.06.2018, her custody shall again be given to the father on 19.06.2018 which would remain with him till 30.06.2018 by 6 p.m. when the custody shall be handed over back to the mother.

The civil appeal stands disposed of.

Other visitation rights as per the earlier arrangement shall continue to operate.
