O R D E R

We have heard the learned counsel for the parties.

Having regard to the grounds on which transfer has been prayed for, we are satisfied with the grievance expressed by the petitioner and we accept the same. Therefore, case bearing Application No. 319/2017 titled "Amar G. Murlidharan vs. Vandana Amar Murlidharan" pending before the Court of Magistrate, Family Court, Pune is ordered to be transferred to the Family Courts at Indore, Madhya Pradesh. The Family Court at Pune shall send the case record to the transferee Court promptly and without any delay.

We find that the petitioner has filed a case under Section 125 Cr.P.C. which is pending before the Court of Presiding Officer, Family Court, Indore. Since this case is also going to be dealt with by the

same Court, the Family Court, Indore, would make an endeavour to fix same date for both the cases.

The Transfer Petition is, accordingly, allowed.
