**OFFICE REPORT**

The matters above-mentioned were listed before the Hon'ble Court on 25<sup>th</sup> January, 2017 alongwith C.A. No. 4390 of 2014 , when the Hon'ble Court was pleased to dispose of C.A. No. 4390 of 2014. Copy of order in C.A. No.4390/2014 is awaited.

Service Position in each of the matter is as under :

**CIVIL APPEAL NO.4391 OF 2014**

It is submitted that there are two respondents in this matter and service of notice is complete at SLP stage, but no one has filed Vakalatnama/ Appearance on behalf of the respondents so far.

**CIVIL APPEAL NO.4392 OF 2014**

It is submitted that there are two respondents in this matter. Service of Notice of Lodgement of Petition of Appeal is complete as Respondent No.1 is represented through Mr. M.P.Devanath, Advocate and Respondent No.2 is represented through Mr. Satyendra Kumar, Advocate.

**CIVIL APPEAL NO.1041 OF 2017 (arising out of SLP 20535 of 2016)**

It is submitted that matter above-mentioned was listed before Hon'ble Court on 23.1.2017, when the Court was pleased to pass the following order:

**“Leave granted.**  
**Tag with Civil Appeal No.4390 of 2014”**

It is submitted that counsel for the appellant has not filed spare copies of Petition of Appeal. Hence Notice of Lodgment of Petition of Appeal could not be issued to the unserved Respondents through High Court.

It is further submitted that there are five respondents in this matter. Mrs. Sarla Chandra and Mr. Snehasish Mukherjee, Advocates have filed Vakalatnama/Appearance on behalf of Respondent Nos. 1 and 2 respectively.

It is also submitted that copy of show cause notice was issued (at SLP stage) to Mr. B.K. Prasad, Advocate (standing counsel for the Union of India), but he has not filed Vakalatnama/ Appearance on behalf of Respondent Nos. 3 to 5/Union of India so far in view of this Hon'ble Court's Order dated 18<sup>th</sup> July, 2016.

It is further submitted that Dasti notice were also handed over to the counsel for the Petitioners for effecting service on respondent nos. 3 to 5 at SLP stage, but he has not filed affidavit of service so far.

Service is complete on respondent nos. 1 and 2.

It is lastly submitted that counsel for the Appellant – State has not filed proof of deposit of Rs. 10, 00, 000/- before the Hon'ble High Court of Tripura so far in view of this Hon'ble Court's Order dated 9<sup>th</sup> November, 2016.

**SLP © NOS.1105, 1106 and 1107 OF 2016**

These matters were listed before the Hon'ble Court on 8<sup>th</sup> January 2016, when the Court was pleased to pass the following orders:

Accordingly, show cause notice was issued to both the Respondents through Registered A.D. Post on 22<sup>nd</sup> January 2016. Mr. Kanhaiya Singhal, Advocate has on 22<sup>nd</sup> July 2016 filed Vakalatnama/ Appearance on behalf of Respondent No.1, but he has not filed Counter Affidavit so far. Unserved cover containing the said notice has been received back from Respondent No.2 with postal remarks “Incorrect Address”. ...3/-

It is submitted that pursuant to Learned Registrar Court's Order dated 5<sup>th</sup> December 2016, fresh Show Cause Notice was issued to Respondent No.2 on 7<sup>th</sup> January 2017 through Registered A.D. Post. Service of notice is awaited.

Accordingly, show cause notice was issued to both the Respondents through Registered A.D. Post on 19<sup>th</sup> January 2016. M/s. Dua Associates, Advocates has on 22<sup>nd</sup> July 2016 filed Vakalatnama/ Appearance on behalf of Respondent No.1. As per report of postal authorities, show cause notice was served on 13<sup>th</sup> October 2016 on Respondent No.2, but no one has filed Vakalatnama/ Appearance on behalf of said Respondent so far.

It is submitted that M/s. Dua Associates, Advocates has on 18<sup>th</sup> October 2016 filed Counter Affidavit on behalf of Respondent No.1. Copies of the same have been included in Paper Books.

Accordingly, show cause notice was issued to all the three Respondents through Registered A.D. Post on 21<sup>st</sup> January 2016. Mr. Naveen Kumar and Mr. Snehasish Mukherjee, Advocates have on 29<sup>th</sup> February 2016 and 4<sup>th</sup> April 2016 filed Vakalatnama/ Appearance on behalf of Respondent Nos.1 and 2 respectively. As per report of postal authorities, show cause notice has been served on respondent no. 3 on 21<sup>st</sup> October 2016, but no one has filed Vakalatnama/ Appearance on behalf of said Respondent so far.

It is submitted that Mr. Snehasish Mukherjee, Advocate has on 7<sup>th</sup> May 2016 filed Counter Affidavit on behalf of Respondent No.2. Copies of the same have been included in Paper Books.

**SLP © NO.27299 OF 2016**

The matter was listed before the Hon'ble Court on 14<sup>th</sup> September 2016, when the Court was pleased to pass the following orders:

**We are informed that the contempt proceedings have been initiated against the petitioners. Those contempt proceedings shall remain stayed till further orders.”**

Accordingly, show cause notice was issued to Respondent No.1 through Mr. Mayank Pandey, Advocate, who has already filed Caveat/ Vakalatnama/ Appearance on behalf of Respondent No.1 and Respondent No.2 through Registered A.D. Post on 24<sup>th</sup> September 2016. Neither A.D. Card nor unserved cover containing the said notice has been received back from Respondent No.2 so far.

The matters alongwith application above-mentioned are listed before the Hon'ble Court with this office report.
