ORDER

This transfer petition has been filed by the petitioner – wife for transfer of Civil Suit No. 943 of 2015 titled “Narendra Singh Dharmasaktu Versus Smt. Bhavna” from the Family Court, Bijnour, Uttar Pradesh to the Court of Principal Judge, Family Court at Haldwani, District-Nainital, State of Uttarakhand.

Despite service of notice, the respondent has not appeared. Hence, averments made in the transfer petition remain un rebutted.

Looking to the facts and circumstances of this case, particularly the fact that the petitioner would be put to considerable inconvenience in prosecuting the matter at the Family Court, Bijnour, Uttar Pradesh we think it appropriate to transfer the aforesaid case from the Family Court, Bijnour, Uttar Pradesh to the Court of Principal Judge, Family Court at Haldwani, District-Nainital, State of Uttarakhand.

After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
