O R D E R

1. The matter was passed over once and called a second time. None appears for the respondent.

2. We have heard learned counsel for the petitioner and perused the pleadings including the counter affidavit filed by the respondent.

3. Having regard to the grounds on which transfer has been prayed for, we are satisfied that it is a fit case for transfer as prayed for. Therefore, case bearing Matrimonial Petition No.01 of 2017 titled as "Shri Bikilal Gupta Vs. Smt. Pooja Gupta" pending before Court of the Principal Judge, Family Court-II, Kohima, Nagaland is ordered to be transferred to the Principal Judge, Family Court, Rohini, Delhi.
