



agreement dated 29.07.2019 has been placed on record under the cover of the report of the Mediator. The parties are now divorced and the wife has undertaken not to challenge the same. The financial terms have been worked out as set out in the settlement agreement. The settlement agreement is taken on record. The husband undertakes before this court that the payment schedule given in the settlement agreement shall be adhered to.

The criminal proceedings mentioned in paragraph 3 of the settlement agreement are accordingly quashed being (a) Criminal Case No.9025 of 2016, pending before C.J.M,, District Unnao, Uttar Pradesh filed by Respondent No.1 against the petitioners herein and the respondent No.2; (b) Criminal Misc. Case No.1836 of 2017, Criminal Misc. Case No.1967 of 2017 and Criminal Misc. Case No.2109 of 2017 filed by the petitioners and the respondent no.2 pending before the High Court of Judicature at Allahabad, Bench at Lucknow, Uttar Pradesh.

All the proceedings *inter se* parties thus stand resolved. A decree be passed in terms of the settlement.

The transfer petition accordingly stands disposed of.
