**UPON hearing the counsel the Court made the following
O R D E R**

1. Ms. Aishwarya Bhati, learned Additional Solicitor General appearing for the State of Uttar Pradesh submits that acceding to the request contained in our order dated 04th February, 2026, the State of Uttar Pradesh, in the peculiar circumstances of this case, is ready and willing to consider appointment of candidates who are likely to be included upon becoming eligible to figure in the re-drawn select list, in terms of the judgment and order of the High Court dated 13th August, 2024, subject to there being existing vacancies, subject to

candidates fulfilling the minimum qualifications, and subject to such exercise not being treated as a precedent in future cases.

2. We appreciate the decision taken by the State of Uttar Pradesh and grant it six weeks' time to complete the aforesaid exercise.

3. A status report shall be placed before this Court on the returnable date.

4. List on 21st July, 2026 before the regular Bench.

5. The special leave petitions and the connected applications shall not be treated as a part-heard.
