2. Shri Siddharth Dave, learned senior counsel appearing for respondent No. 2 submitted that his evidence is hearsay. Whether it is so, is the matter which shall be determined at the time of trial and this cannot be prejudged today at this stage.

3. We, therefore, set aside the order of the High Court with the direction as above.

4. We may note that the trial may not be delayed on this count.

5. The appeal is allowed accordingly.
