O R D E R

1. Leave granted.
2. We have heard learned counsels for the parties and perused the relevant material.
3. The accused-appellant, who is about seventy years old, is in custody since 26th June, 2016. Charge-sheet has been filed though it appears that further investigation under Section 173(8) of Cr.P.C. is going on. We have also considered the allegations against the accused-appellant.
4. Taking into account the age of the accused-appellant and the period of custody suffered and the fact that charge-sheet has been submitted, we are of the view that the accused-appellant should be released on bail.

We order accordingly and direct that the accused appellant be released on bail to the satisfaction of the learned J.M.F.C., Indore in Crime No.13 of 2016.

5. The learned trial Court is free to impose all such conditions as it may deem fit.

6. The order of the High Court is set aside and the appeal is allowed.
