This transfer petition has been filed by the petitioner - wife for transfer of Original Suit No.523 of 2018 titled "Akshat Joshi Vs. Sakshi Sharma" from the Court of Principal Judge, Family Court, Dehradun, Uttarakhand to the Family Court at Kota, Rajasthan.
