While allowing Transfer Petition (Civil) No.2076 of 2018, it was directed that the proceedings be transferred to the Family Court at Alipore, Kolkata. This application states that there is no Family Court at Alipore, Kolkata and, as such, no transfer could be effected despite aforesaid direction.
