O R D E R

In the instant petition seeking transfer of the petition filed by the respondent-husband for Restitution of Conjugal Rights, the effort of Mediation has failed.

In that view, the learned counsel for the respondent submits that the petition filed under Section 9 of the Hindu Marriage Act, 1955 before the Principal Judge, Shahdara District, Family Court, Shahdara, Karkardooma, Delhi would be withdrawn by the respondent herein.

In view of the said submission, the instant transfer petition would not survive for consideration. Accordingly, the petition is disposed of. Consequently, the interim order granted earlier stands vacated.

It is made clear that the respondent-husband shall withdraw the petition pending before the Principal Judge, Shahdara District, Family Court, Shahdara, Karkardooma, Delhi as undertaken, within two weeks from this date, failing which

the said petition would stand transferred to the Family Court,
Nagpur, Maharashtra.

The Transfer Petition is disposed of accordingly.
