O R D E R

C.A. No. 4106/2020

Service is complete on respondent nos. 1 to 5 but none has entered appearance.

Respondent no.6 has failed to file counter affidavit despite last opportunity having been granted. However, respondent no.6 (who is appellant in CA No.694/2021) submits that the said appeal may be treated as counter affidavit as he has already stated all the grounds therein. The said submission be incorporated in the office report, as and when the matter is listed before the Hon'ble Court.
