**O R D E R**

This transfer petition has been filed by the petitioner-wife seeking transfer of Divorce Petition bearing Case No.07 of 2019 C.M. filed by the respondent-husband before the Family Court, Chittorgarh, Rajasthan to the Court of competent jurisdiction at Ahmedabad, Gujarat.

On 17.12.2019, notice was issued by this Court and an interim order was passed staying further proceedings of Divorce Petition bearing Case No.07/2019 C.M. It was directed that the process be additionally served through the Court where the proceedings were pending.

According to the office report, service of notice has been effected upon the respondent through the concerned Trial Court. However, the respondent has chosen not to enter appearance in this Court.

We have heard learned counsel for the petitioner and perused the record.

Considering the facts and circumstances on the record, we deem it appropriate to allow this transfer petition.

Consequently, the Divorce Petition bearing Case No.07 of 2019 C.M. titled as "*Brijesh Parihar v. Smt. Usha Parihar*", filed by the respondent-husband before the Family Court, Chittorgarh, Rajasthan is transferred to the Family Court, Ahmedabad, Gujarat.

The Family Court at Chittorgarh is directed to transmit the entire record to the transferee court immediately.

The Registry is directed to send a copy of this Order to both the Courts for compliance.

This transfer petition is allowed accordingly.
