- 1 This transfer petition has been filed by the petitioner - wife for transfer of Marriage Petition No 415 of 2019 titled "Fagun Ashokkumar Lakhani Vs Aarti Rajeshbhai Patel alias Aarti Vimal Patel @ Aarti Fagun Lakhani" from the Court of Civil Judge, Senior Division at Vasai, District Palghar, Maharashtra to the Family Court at Ahmedabad, Gujarat.
- 2 We have heard learned counsel for the parties.
- 3 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. - 4 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.
- 5 After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
- 6 Pending application, if any, stands disposed of.
