O R D E R

Having heard the learned ASG for the petitioner(s) as also the learned senior counsel for the respondent(s) and having perused the petition papers, we note that as against the award passed on 13.08.2009, the petitioner(s) has filed proceedings under Section 34 of the Arbitration and Conciliation Act, 1996 (for short 'the Act') wherein it was upheld through the judgment date 31.03.2018 and also confirmed through the impugned judgment dated 23.07.2019 in the appeals under Section 37 of the Act.
