UPON hearing the counsel the Court made the following
O R D E R

While passing the order dated 25.11.2019 we were informed that the power to conduct elections were conferred on R.3 and 4. Therefore we had directed respondent Nos. 3 and 4 to initiate the

electoral process and complete the same by 28.2.2020. By means of this application we are informed that actually the power to conduct the elections vests with the State Cooperative Election Authority Maharashtra State, Pune. We would have expected such Authority to comply with our orders but it appears that the State Cooperative Election Authority took a very technical objection that since the Authority was not a party out earlier order would not bind it. We are not happy with the stand taken. Be that as it may, without impleading the State Authority as a respondent, we direct the State Authority which is vested with the power of conducting elections to comply with our orders dated 25.11.2019. However we extend the period for completion of the election process to 31st March, 2020.
