O R D E R

1. Delay condoned.
2. Leave granted.
3. This appeal takes exception to the order dated 14.06.2019 passed by the High Court of Judicature at Madras in Cr1. R.C. No.478 of 2019. The High Court rejected the said revision solely on the ground that the appellant had not surrendered despite the direction given by the Court in that behalf.
4. The appellant, after filing this appeal, was directed to surrender and he has done so on 13.02.2020. Resultantly, instead of examining the matter on merits in this appeal, we deem it appropriate to relegate the parties before the High Court for consideration of revision petition on merits in accordance with law. We order accordingly.

5. The appellant is free to move the High Court for early hearing of revision petition including to ask for interim relief, if so advised, which request be considered by the High Court appropriately.

6. The appeal and pending applications are disposed of.
