O R D E R

Having given due consideration to the averments made in the transfer petition, and in the interest of justice, we are inclined to allow the transfer petition.

Accordingly, the transfer petition is allowed and O. P. No. 1204 of 2019, titled '*Suchis Kumar Khatiwala Versus Shefali Suchis Khatiwala*' pending before the Family Court Judge at City Civil Court, Hyderabad, Telangana is directed to be transferred to the Court of Presiding Judge, Family Court at Surat, Gujarat, who may hear the case himself or assign it to a court of competent jurisdiction.

Records of the case would be immediately transferred to the transferee court.

The parties are directed to appear, either in person or through authorized representative, before the transferee court on 28th October, 2022. However, in case there is non-appearance, court notice would be issued to the defaulting party.

The parties may explore the possibility of settlement through mediation. The transferee court would obtain the desire and wishes of the parties and proceed accordingly in this regard.
