We have also perused the counter affidavit filed on behalf of the respondent Bank. Having heard the learned counsel for the parties and considering the pleadings, it appears that there are serious disputes with respect to the entitlement of the amount due and payable under the order passed by the High Court and confirmed by this Court.

By and large, the order passed by the Learned Single Judge and confirmed by this Court seems to have been complied with. Therefore, we see no reason to continue the present contempt proceedings and we close the contempt proceedings.

However, it is observed that if there is any dispute with respect to the entitlement, it will be open for the petitioners to move representation or they may agitate the issue in independent proceedings before appropriate forum.

With this, the present Contempt Petitions stand disposed of.
