Leave granted.

The order impugned in this appeal is to reject the prayer of the appellant to modify the bail condition imposed by the Additional Sessions Judge, Yavatmal vide order dated 06.03.2019 in Criminal Bail Application No.64/2019.

First condition is to furnish cash surety of Rs.10,00,000/- (Rupees ten lakhs only) for being released on bail. That has already been complied by the appellant. The second condition is to furnish cash surety of Rs.15,00,000/- (Rupees fifteen lakhs only) within three months from the date of the said order, which the appellant has not been able to comply so far. He prays for two weeks' time to provide solvent surety instead of cash surety for the like amount.

Although, this prayer is opposed by the counsel for the respondent-State, we fail to understand as to what purpose will be served by insisting upon the appellant to deposit cash surety instead of solvent surety.

As prayed by the counsel for the appellant and in the peculiar facts of the present case, we are inclined to grant two weeks' time to the appellant to furnish solvent surety in the amount of Rs.15,00,000/- (Rupees fifteen lakhs only) to the satisfaction of the trial Court. We order accordingly.

The appeal is allowed in the above terms.
