UPON hearing the counsel the Court made the following  
O R D E R

In this petition, the respondent-Delhi Development Authority seeks recall of the order dated 16.12.2019 whereby this Court had extended the time to vacate the land upto 31.3.2020.

This order was passed just before the Winter Vacation of the Court and we passed the order without issuing notice to the DDA. We were unaware of the order passed by the another Bench of this Court rejecting the similar M.A. No.2522/2019 in SLP(C)No.7814/2018.

Mr. Manan Kr. Mishra, learned Senior Advocate prays for rejecting the present application by recalling of order dated 16.12.2019 on the ground that the prayer made in M.A. No.2522/2019 in SLP(C)No.7814/2018 was different from the prayer for extension of time in M.A. No.2567-2569/2019 in SLP(C)Nos. 33490-33492/2016 which was granted vide order dated 16.12.2019. He submits that the prayer in that Miscellaneous Application was for allotment of alternate plots/land and for time to be extended until the alternative plots/lands were allotted.

Be that as it may, we have already extended the time upto 31.3.2020, out of which almost 1/3rd of the time has already expired. Keeping in view the peculiar facts and circumstances, the applications for recall of order dated 16.12.2019 is rejected.

We make it clear that this order has been passed in the peculiar circumstances of the case when we were not aware of the order passed by the Coordinate Bench and it shall not be treated to be precedent or relied on in any other case.

The M.As. are disposed of.

Pending applications, if any, also stands disposed of.
