**ORDER**

- 1 This transfer petition has been filed by the petitioner-wife for transfer of Case No DMC-514/2019, titled "*Suresh Kumar Yadav vs Nidhi Yadav*" from the court of Principal Judge, Family Court, Rewari, Haryana to the court of Principal Judge, Family Court, Jaipur, Rajasthan.
- 2 We have heard counsel for the parties.
- 3 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that Case No DMC-514/2019, titled "*Suresh Kumar Yadav vs Nidhi Yadav*" be transferred from the court of Principal Judge, Family Court, Rewari, Haryana to the court of Principal Judge, Family Court, Jaipur, Rajasthan.

- 4 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.
- 5 After transfer of the petition, the transferee court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
- 6 Pending applications, if any, stand disposed of.
