O R D E R

SLP(C) Nos. 13267/2020 and 14901/2020

Four weeks time, is granted as a last chance to respondent nos. 1, 3 to 6, 8, 9 and 18, to file counter affidavit.

Two weeks time, is granted to cure the defects in vakalatnama filed on behalf of respondent no. 7 and four weeks time to file counter affidavit.

Despite due service on respondent nos. 2, 10 to 17, there is no appearance.

At this stage, Mr. G. G. Kashyap, Ld. Advocate appearing for Mr. Rishi Malhotra, Ld. AOR seeks for time to file vakalatnama on

behalf of respondent no. 12. Two weeks time is granted to file vakalatnama and four weeks time to file counter affidavit.

Ld. Counsel for petitioner to serve soft copy of the petition on the Ld. AOR for respondent no. 12 within a week.

List again on 12.04.2023.

SLP(C) No. 4351/21

Ld. Counsel for petitioner has failed to file spare copies for issuance of notice to respondents in terms of order of the Hon'ble Court dated 08.10.2021.

As requested, two weeks time, is however granted, as a last chance for the same.
