The instant appeal, by way of special leave, is directed against order dated 23.09.2013 passed by the High Court of Karnataka at Bangalore in Criminal Revision Petition No.134/2013 whereby the High Court dismissed the criminal revision petition filed by the appellant herein.

On 14.09.2016, this Court passed the following order:
