Two separate orders, one by Hon'ble the Chief Justice, Hon'ble Mr. Justice Abhay S. Oka, Hon'ble Mr. Justice M.M. Sundresh, Hon'ble Mr. Justice J.B. Pardiwala, Hon'ble Mr. Justice Manoj Misra, Hon'ble Mr. Justice Ujjal Bhuyan, Hon'ble Mr. Justice Satish Chandra Sharma and Hon'ble Mr. Justice Augustine George Masih, and dissenting order by Hon'ble Mrs. Justice B.V. Nagarathna, have been passed.

In terms of the separate and dissenting order, applications seeking permission to file the review petitions are allowed; applications for listing the review petitions in open Court are allowed; notice is issued to the respondents on the applications seeking condonation of delay as well as on the review petitions and interim prayers made therein.
